

**SPOKANE LILAC FESTIVAL ASSOCIATION  
CANDIDATE'S AGREEMENT**

1. I am a full-time high school female student, currently residing within Spokane County and will continue to reside in these boundaries until graduation 2014.
2. I have an accumulated grade point average of at least 3.0 based on a 4.0 system, good citizenship and school attendance and I will be graduating in June 2014.
3. I have never been married, divorced, had a marriage annulled, and agree not to marry until after Coronation 2015.
4. I have never been pregnant or given birth to a child and agree to remain childless until after Coronation 2015.
5. I have never been convicted of a crime.
6. I do not have visible body tattoos or excessive piercing.
7. I do not hold another crown or title.
8. I will refrain from possessing, selling or any personal involvement with alcohol, any controlled substance, or non-prescription mind, personality, or mood altering substance from the time I sign this document through my tenure as royalty.
9. I will not use or possess tobacco products while representing Spokane Lilac Festival Association.
10. I promise that I will be on time and available for all scheduled events. I am aware that the Spokane Lilac Festival will schedule appearances during school hours, evenings, weekends, and during the summer. I am able and willing to carry out the duties and responsibilities as a Royalty Candidate, as member of the Festival Royalty Court. After 3 absences I may be dismissed as a Candidate.
11. I realize that the Festival Chaperones and Festival Tour Escorts are responsible for my care and protection. I understand they will contact my parents if I do not arrive at the designated event at the appointed time. They have instructions to deliver Festival Royalty back to only their homes, a previously agreed-upon location, or school.
12. I understand that if I am selected as a member of the Festival Royalty, I will not sign any management contract, other than this Candidate's Agreement. I will not give any written, verbal, or visual endorsement of any commodity or service not associated with the Spokane Lilac Festival. I will not make any unauthorized public appearances or give any interviews.
13. I agree not to enter any other royalty contests or pageants until after Coronation 2015, if chosen as a member of the Festival Royalty.
14. I understand that I may be called before the Festival's Board of Directors for the possibility of removal from the Royalty Court and forfeiture of all gifts, titles, clothing, scholarship moneys or other presentations provided to me as a member of Festival Royalty if I fail at any time to conform to the terms of this Candidate's Agreement, or state anything in this agreement or the Candidate's Application, that is not true or misleading.
15. I acknowledge that the Festival reserves the right to conduct the Royalty Selection Process according to the procedures now in effect, or as may be amended by the Festival's Board of Directors. I acknowledge that the Festival selects or approves all clothing that must be worn by Festival Royalty. I agree that by my participation in the Royalty Selection Process, I waive any right to contest any aspect of the judging or Royalty Selection Process.
16. I grant the Spokane Lilac Festival Association permission to take and reproduce pictures taken with the Fab 14. I understand these photographs may be used for memorabilia for the court and will not be sold to any person or publication.
